CHAPTER 1: Getting Started

Before installing, setting up or operating this equipment, make sure you have read and fully understand all of the "IMPORTANT SAFETY INSTRUCTIONS" at the end of this document.

Important: You must set up the IP address and netmask of your computer (PC Windows 10 32/64 bits or MAC OS X) before using it for the first time.

Unpacking

Carefully unpack your Fast equipment package. Then, inspect the device for any signs of damage that may have occurred during transit and notify the courier immediately if you discover any. Please retain the original packing in case you should need to return the equipment to the manufacturer or supplier, or transport or ship the unit later.

Installation

When installing the unit, take the following into consideration.

- Do not install the equipment in places of poor ventilation.
- Do not install this equipment in a location subjected to excessive heat, dust, or mechanical vibration.

Allow for adequate ventilation around the equipment, making sure that its vents are not obstructed. • This 1U rack unit is designed for mounting in any 19" EIA standard rack. . GHOST, FAST2 and H1 units complement each other. All these devices can coexist in the same network topology. Your Fast2 was developed by Agora to offer AV professionals a high-performance dual network switch equipment, designed to provide no-compromise network builder and an easy-to-use interface to build the most complex networked system in a minimum of time.

All this is backed up, of course, by five years warranty for all materials and accessories. Finally, enjoy your Fast2 dual network switch system!

About

The Fast2 System provides:

- One fully configurable "Primary" switch with by default:
 - 5 User ports (4 Ethercon[™] on the front panel (P1 to P4) and 1 Ethercon[™] on the rear panel (P5)
 - 1 Control Port on the rear panel (P6).
 - 2 Transmit ports for units interconnexion:
 - T1: Optional Gigabit 1000BaseX OpticalCon[™] or SmartBeam[™] Duo ports

in Single mode or Multimode (chosen at purchase)

- T3: Gigabit Ethercon[™] port on the front panel.
- One fully configurable "Secondary" switch with by default:
 - 6 User ports (4 Ethercon[™] on the front panel (S1 to S4) and 2 Ethercon[™] on the rear panel (S5,S6)
 - 2 Transmit ports for units interconnexion:



OpticalQuad[™] option (chosen at purchase): Unused dual fibers are reported to the Back panel on an OpticalCon Duo port.



FNCT Button / Device LED

Fixed Green LED: Normal status, User Ports ID LEDs show User Groups colours.

FNCT

Flashing Green LED: Identify device with Agora Controller

Flashing Blue LED: Service mode during Firmware Upgrade

From Fixed **Green** LED:

• Press FNCT Button once:

Yellow LED:User Ports Status LEDs show Port speed:None = 10Mbps, Flashing= 100Mbps, Fixed=1000Mbps

- Press FNCT Button twice: Red LED: not implemented
- Long Press FNCT Button TWICE: White flashing LED: Press once to <u>Reset the IP address at 192.168.1.101/24</u>

Fast2 Internal Link mode

Fast2 has to considered differently from Ghost and H series as it is a "dual switch" device.

The Master Controller Unit (MCU) is in charge of Function Button and DeviceLED, Ports ID/Status/Traffic LEDS The internal gigabit Ethernet link has 3 possible configuration modes:

• OPEN

Internal link between Primary and Secondary switch is **deactivated**.



DUAL

Only Ctrl Group (VLAN 256) is transmitted between Primary and Secondary switches for Software Control



• SINGLE

All User Groups (All VLANs) are transmitted between Primary and Secondary switches

Important notes:

- IP addresses:
 - The Secondary IP address is automatically configured from the Primary IP address adding 1 to the last Byte. i.e Primary IP address: 192.168.1.101/24 gives Secondary IP address: 192.168.1.102/24
- Agora Controller DO NOT allow control of an "half-discovered" Fast2. Both Primary and Secondary have to be discovered among the VLAN 256.

When OPEN mode is selected, the Secondary unit CANNOT be not directly controlled from the Primary unit of the same device.

In this case the Secondary unit has to be reached by its transmit ports from another Agora device (Ghost, H1, Fast in Dual or Single mode)

Tip: an Ethernet cable can also be plugged between T3 and T4 to simulate Dual mode.

• Multiple DUAL and/or SINGLE Fast2 topologies have to be used with care as the internal links between Primary and Secondary units participate in RSTP protocol.

Please refer to the technical note *"Rapid Spanning Tree Protocol: Best practice for redundancy on Ethernet AV networks"* and see also Chapter 5 for topologies examples.




Fig.3 Full Open mode







Fig.4 Only one Dual or Single device: Valid loop-free topology





Fig.5 Only one Dual or Single device: Valid loop-free topology






Fig.6 Multiple Dual and/or Single devices: Looped topology




Fig.7 Fast2 Single mode

Example of Redundancy management for AV & Remote protocols

Dante "seamless" redundancy :

- Dante Primary is assigned on Primary units
- Dante Secondary is assigned on Secondary units
- Redundancy is guaranteed by Dante end points

Other protocols redundancy:

- Guaranteed by RSTP (few seconds convergence)
- Adjust Bridge priorities in order to force the Fast2 B internal link to be deactivated.

Chapter 6: Service and maintenance information

Routine Maintenance

To help keep your Fast2 unit in good working order and to make sure it gives you optimum performance, we recommend that you carry out the following at monthly intervals:

- Clean the unit (see "Cleaning" below).
- Check the controls for freedom of operation.
- Check the functionality of all controls, that is, control knobs, pushbuttons, and LEDs.

You can carry out a visual check of all illuminated items (LEDs etc.) by switching the unit off and then on again, as they should all illuminate during power up.

• Check the functionality of the equipment.

Cleaning

Switch off the unit and electrically isolate it from the mains *before* cleaning. Clean the Fast2 device using a dry, lint-free cloth. Do not use harsh abrasives or solvents. When cleaning the unit, take great care not to damage control knobs, pushbuttons etc.
