INTRODUCTION

Although 4K UltraHD has arrived, not every client will immediately abandon their existing HD screens, so the ability to support a combination of 4K and 1080p HD displays within the same distribution is critical, especially when resolution conflicts that affect systems, including screens of varying capabilities, are taken into account.

The P8-HDMI DAC video scaler and digital audio converter (DAC) is intended to be used in conjunction with a display and a source device. It scales the output to a level compatible with its display capabilities after adjusting the resolution and audio from an incoming HDMI source.

This product is ideal for integrating HD and 4K sources and displays into a multi-zone residential or commercial distribution system.




PANEL DESCRIPTIONS



- A HDMI Out Use Connect to HDMI sink device (i.e TV) to this port using an HDMI cable.
- B Stereo Out 3.5mm audio breakout.
- Over Status LED light

INSTALLATION

- DC 5V Use the supplied mains power cable and connect to the chassis. Do not use any other power cables with this product.
- **E** Audio Selection Switch Select between bypass or downmix of the audio.
- **(F)** Video Selection Switch Select between upscale or downscale bypass of the video.
- G HDMI In Connect to an HDMI source device (i.e Blu-Ray player) to this port using an HDMI cable.

- 1. Connect HDMI cables from your video sources (e.g. Blu-Ray player) to the 'HDMI In' port using an HDMI cable.
- 2. Connect the 'HDMI Out' port to the sink device (i.e. TV) using an HDMI cable.
- 3. Switch the video and audio selector.
 - Upscale 1080p to 4K resolution.
 - Downscale 4K to 1080p.
 - Bypass No alteration of the audio.
 - Downmix Downmixing a 5.1 surround mix into stereo.
- 4. The audio signal will be transmitted via HDMI. However, the HDMI DAC includes the ability to output sound to a Soundbar or another audio output if you prefer to route your audio directly from the DAC rather than through the display.
- 5. Use the supplied power supply and connect to the DC 5V port.
- INote: HDMI DAC does not support downscaling for Sky Q 2TB or Virgin V6 4K content please use the HDMI UHD 18Gbps Downscaler (P8-HDMI2-4KDS)



TROUBLESHOOTING

Should you encounter installation difficulties or issues with device communication, the following checklist of common issues and causes should help resolve your issues. If you still continue to experience issues, please contact your local representative for further assistance.

No Video

- Connected and powered? Double check that all HDMI, and power cables are firmly connected to the correct ports and all devices are correctly powered.
- Cable quality and condition HDMI cable/connectors can easily be damaged and the quality of material can vary. Always use good quality leads and cables and try swapping cables that are known to be working into the solution to see if this improves your image.

No Audio

- Check the source, and if the output is channeled into optical or coax.
- Switch the source to the other if possible. (For example, if switching from optical to S/PDIF or TOSLINK to coax).
- If possible, try different RCA sources at the output.
- If you still do not receive a response, please contact a Pulse-Eight representative or your Installer.

Please Note: Warranty cover for ALL products starts from date of receipt of goods NOT date of installation. Should we find that your product does need replacing, we will send your replacement directly to the distributor you purchased from, if not purchased directly from Pulse-Eight.

- 1. Contact support via phone or a support ticket. Pulse-Eight will try to help troubleshoot and resolve the issue remotely.
- 2. If unable to resolve the fault remotely and the unit needs replacing an advanced replacement will be raised with the installer who purchased it. If you purchased from a distributor you will need to return to your distributor and they will contact Pulse-Eight to get the RMA raised. All distributor advanced replacements will be sent to the distributor and cannot be sent direct to their installer.
